# **“A TASTE OF MEMPHIS” FOOD VENDOR RULES**

- Set up will occur from 1:00 p.m. – 4:00 p.m. at TIGER LANE- 450 Early Maxwell Blvd. Memphis, TN. 38104
- No use of tent.
- All food trucks must have proper permits and health department certificates on file in their trucks to present to when needed.
- All trucks must sell Coke products only. This includes but is not limited to water (Dasani Only), soda, juice, energy drinks, etc.
- There is no staking signage, flags, or banners in the grass or any other area on property.
- No additional power except for the 110v/20amp outlets available on Tiger Lane. Should they blow one of those circuits or outlets they will be without power unless Taste of Memphis hires a General Services electrician at \$64 an hour for a 4 hour minimum to be on site to make repairs as needed, if this fee is incurred the fee will be the responsibility of the Food truck.
- They must adhere to all other rules and regulations set forth by the City of Memphis for food trucks and health codes.

## Hold Harmless.

Vendor shall defend, indemnify, and hold the City of Memphis harmless from any and all actual or alleged claims, demands, causes of action, liability, loss, damage and/or injury (to property or persons, including without limitation wrongful death), whether brought by an individual or other entity, or imposed by a court of law or by administrative action of any federal, state, or local governmental body or agency, arising out of or incident to any acts, omissions, negligence, or willful misconduct of Vendor, its personnel, employees, agents, contractors, or volunteers in connection with or arising out of Vendor's exhibition at the Conference. This indemnification applies to and includes, without limitation, the payment of all penalties, fines, judgments, awards, decrees, attorney's fees, and related costs or expenses, and any reimbursements to City for all legal expenses and costs incurred by it.
